Aims and Objectives of the Sripat Singh College Alumni Association

The aims and objectives of the Association are as follows:

1. To provide a forum for members of the Alumni Association (hereinafter referred to as "Members") to interact with one another, as well as with the Principal, faculty, and current students of Sripat Singh College, Jiaganj, Murshidabad, PIN-742123 (hereinafter referred to as "the College").

2. To bring together the ex-students of Sripat Singh College and promote fellowship among them and their families.

3. To disseminate knowledge and expertise for the mutual benefit of the Members and the College.

4. To undertake the following activities:

(i) Intellectual, academic, and cultural activities (ii) Sports and games

(iii) Entertainment programs

(iv) Improvements to the existing infrastructure of the College

(v) Social service initiatives for the benefit of the Members, the College, and society at large, including:

a. Creating a website for the Association to upload relevant information for the benefit of all Members.

b. Conducting academic meetings such as conferences, workshops, seminars, symposia, and lectures by eminent personalities for Members and current students/teachers on relevant topics.

c. Instituting and awarding prizes for meritorious students of the College in academics, sports, and extracurricular activities.

d. Organizing activities such as career counseling, medical check-up camps, and other programs for the benefit of current students.

e. Establishing merit-cum-means-based scholarships for needy and deserving students of the College.

f. Mobilizing donations from Members and others for charitable purposes in the event of natural calamities such as earthquakes or floods.

g. Establishing a permanent Corpus Fund to provide need-based financial assistance to Members and current students for medical treatments.

h. Publishing magazines and newsletters to highlight the activities and achievements of the Association.

i. Conducting various activities for Members, such as get-togethers, sports and games, picnics, excursions, and cultural programs.

5. To undertake any other activities in accordance with and in furtherance of the objectives outlined in 1, 2, 3, and 4 above.

6. With prior permission from the College's Principal, the College premises and/or facilities may be utilized by the Association for holding its official programs, functions, or activities in alignment with the Association's objectives. The College premises shall not be used for personal programs, functions, or activities of any Member, whether they are a General/Ordinary Member or an Office Bearer/Committee Member.

7. The affairs of the Association shall be managed by a Managing Committee, which shall comprise an Honorary President, an Honorary Vice President, an Honorary General Secretary, an Honorary Assistant Secretary, an Honorary Treasurer, an Honorary Assistant Treasurer, and four Honorary Committee Members.

8. In achieving the above objectives, the principles of good corporate governance shall be strictly adhered to, and the provisions of The West Bengal Societies Registration Act, 1961, along with the terms and conditions of registration, shall be followed in letter and spirit.

9. The accounting year of the Association shall run from April 1 of one year to March 31 of the following year.

10. All incomes, earnings, movable and immovable properties of the Association shall be utilized solely for the promotion of its objectives as stated above. No portion shall be paid or transferred as dividends, bonuses, profits, or in any other manner to any current or past Members, either directly or indirectly.

11. No Member shall have any claim on the movable or immovable properties or funds of the Association or make any profit by virtue of their Membership.

12. The Memorandum of Association and the Bye-Laws of the Association shall be duly registered under The West Bengal Societies Registration Act, 1961.

13. The President of the Association is authorized to correspond with the Registrar of Societies.
