 - ii. The entire MoU can also be terminated anytime without being a burden for any party, of course, with a minimum of three months' notice from either side.

VI. EFFECTIVE DATE AND SIGNATURE

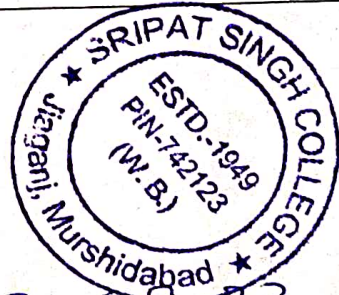
